- Education and Experience Criteria: Should be a Degree/Diploma in Garment Making/ Fashion Design/ Textile/Jute/Handloom, B.Sc(FD) Or M.Sc(FD), B.Sc/M.Sc (Home science)

#### **(From approved institute UGC/AICTE)**

- The experience shall be in teaching or relevant industry. Educational qualification should be relevant to the module for which the assessor is being empanelled.

### **Experience Required:**

- 1+ years Exp. in Textile Sector/ Garment / Tailoring, Dress Making/ Made-Ups etc. in Industry/ Trade/ Teaching ( For Degree Candidates )
- 3 years Exp. in Textile Sector/ Garment / Tailoring, Dress Making/ Made-Ups etc. in Industry/ Trade/ Teaching ( For Diploma Candidates )
- 10 years Exp. in Textile Sector/ Garment / Tailoring, Dress Making/ Made-Ups etc. in Industry/ Trade/ Teaching ( For ITI & Other Relevant Certificate Candidates )

**In the case of traditional sectors like Handicraft, etc., where a formal degree or diploma education is not available, 5-10 years of production/field experience in the relevant sub-sector and trade will be taken as minimum eligibility criteria.
